For ourselves and on behalf of our employer/firm (as identified above), we agree to the following terms to obtain "Guest access" to Cambio for our firm's work for _____ ("Client"). Cambio is BGC's computer program/database that contains information concerning geohazards and certain other risks. In consideration of BGC giving us "Guest access" to Cambio, we agree as follows:

We acknowledge that BGC is providing us "Guest access" to Cambio as a courtesy to us. By doing so, BGC undertakes no duty to us or to our firm.

We will keep all of Client's information and BGC's information confidential. We will immediately report any actual or potential violations of confidentiality to both BGC and Client.

"Guest access" to Cambio is limited to: (a) viewing information in Cambio for work for Client only, and (b) uploading documents related to Client's project into Cambio. We will not use Cambio for any other person, entity, or purpose. "Guest access" does not allow us to change any database parameters, use BGC's forms, or alter inspection reports.

BGC may revoke or revise this permission for "Guest access" to Cambio at any time for any reason, including for Client's or BGC's security or operational reasons. BGC may also limit permission to input data into Cambio, or refuse to accept any data into Cambio. We will not give anyone else access to Cambio (including other members of our firm) without first obtaining BGC's prior written consent to do so.

We confirm that BGC is the sole owner of Cambio and all intellectual property, code, algorithms, and trade secrets in or related to Cambio. We will not copy, alter, design around, or reverse engineer all or any part of Cambio, intellectual property within Cambio, or Cambio's features or functionality. We will not introduce or upload to Cambio any virus, Trojan horse, worm, back-door, or any other malicious or deleterious program or material.

BGC is entitled to immediate injunctive relief to stop or prevent any actual or threatened violation of this document.

We confirm that Cambio access is provided on an “as is” basis, with no warranty of any kind (either express or implied) from BGC related to Cambio or any information in Cambio. Information in Cambio may not be complete, current, accurate, or error-free. We use Cambio and information in Cambio at our own risk. **We hereby release BGC from all liability for any claims, losses, or damages that may result in any way from our use of Cambio or any information in Cambio.** We confirm that: (i) we have authority to bind our firm to the contents of this document, including the release of liability set forth in the previous sentence; and (ii) by signing below, we bind ourselves and our firm to the contents of this document.
